## About Corey

Corey has briefed and argued appeals in several of Ohio's appellate districts and before the Ohio Supreme Court. In December 2020, Corey, along with estate planning colleagues, won a unanimous Ohio Supreme Court reversal that determined that Ohio's Voiding Statute applies to all written wills admitted to Probate Court.

In the healthcare space, Corey represents physicians and hospital systems in professional negligence actions, including medical malpractice, nursing home negligence and pharmaceutical negligence. He lectures frequently to healthcare groups on topics aimed at risk avoidance.

Corey also represents clients in residential and commercial development, manufacturing, federal contracting, and healthcare involving contract disputes, non-compete agreements, and restrictive covenants, as well as on real estate, commercial brokerage and fiduciary duty claims, non-disclosure, and construction defects.
